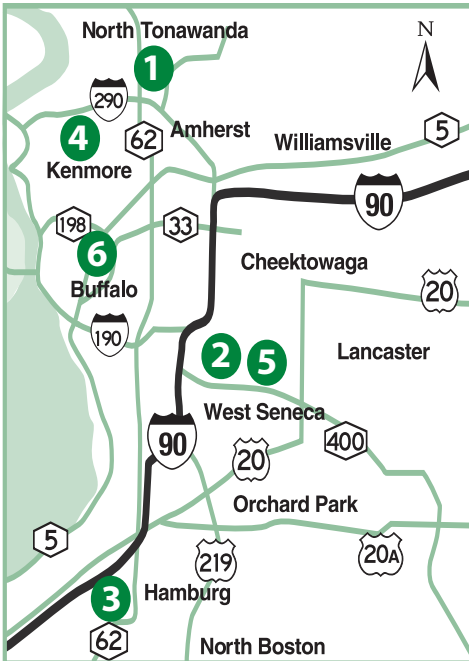
#### **About Lifetime Health Medical Group –**
